# Climate Adaptation Project for the Sierra Nevada Adaptation Planning Workshop June 4-5, 2013

# Workshop 2:

This 1.5-day workshop will include: (1) a review of the results of the vulnerability assessment for focal resources; (2) presentation of spatial analysis and mapping for the region and resources and discussion around how the information can be used to inform regional management decisions; (3) introduction to and exploration of adaptation planning approaches; (4) development of adaptation strategies for the region and resources; and (5) prioritization of adaptation actions including what, where, and who will implement.

# **Workshop 2 Objectives:**

- 1. Collaboratively identify management and conservation goals and objectives for focal resources.
- 2. Present outcomes of spatial analysis and mapping to facilitate adaptation planning.
- 3. Develop adaptation strategies to reduce the identified vulnerabilities of resources (from March workshop) and increase positive long-term outcomes for regional management goals.
- 4. Develop implementation plans to facilitate incorporation of adaptation strategies into regional planning and management activities.
- 5. Provide climate change adaptation training, resources, support, and tools to participants to extend this process to similar efforts in their own work.

# **Background:**

The Climate Adaptation Project for the Sierra Nevada is comprised of three principal components:

- (1) Vulnerability assessment workshop,
- (2) Spatial analysis and comparative mapping to inform the vulnerability assessment and facilitate adaptation planning, and
- (3) Adaptation planning workshop.

The objectives of this project include:

- (1) Assess the vulnerability of focal resources to climate change,
- (2) Use spatial analysis and expert input to prioritize conservation areas or actions,
- (3) Identify implementable management responses to climate change in the Sierra Nevada, and

(4) Provide training for managers, planners and others to conduct similar processes in specific jurisdictions (national forests, counties, reserves, etc.).

# Workshops:

This is the second of two workshops on climate change vulnerability assessment and adaptation planning for the Sierra Nevada. The goal of this workshop (4-5 June 2013) is to develop and prioritize adaptation strategies for focal resources and regions. The goal of the first workshop was to evaluate the vulnerability of a suite of focal resources (ecosystems, species, and ecosystem services) to climate and non-climate stressors and to identify spatial analysis needed to support the vulnerability assessment and adaptation planning.
